

**IMPORTANT DATES RELATING TO BONUS WARRANTS W241022**

**1. INTRODUCTION**

In this announcement, the term “**Warrants**” refers to all bonus warrants issued by the Company, the terms and conditions of which (“**Warrant Conditions**”) are set out in the deed poll executed by the Company on 8 January 2024 (“**Deed Poll**”). **3. EXERCISE PRICE OF THE WARRANTS**

The Exercise Price of each Warrant is S\$0.15 for each New Share.
